BE IT FURTHER RESOLVED that the Chairman or the County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, the necessary documents to receive title to the said vehicle on the conditions that said vehicle shall be used or disposed of and the proceeds thereof used by Forsyth County as an addition to the County's active fleet and that Forsyth County shall waive all rights to make any claims against Forsyth Technical Community College relating to any failure of performance of said vehicle, to which the County agrees by accepting title to the vehicle, all subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
