Bids were received August 23, 2013 for the purchase of twelve 2014 Dodge Charger police pursuit vehicles. Below is a summary of the bids received:

Ilderton, LLC in the amount of \$275,256, with the option to extend the contract at the same annual cost, in one year increments, provided that both parties are in agreement and funds are available for this purpose.

**RESOLUTION AWARDING A CONTRACT FOR THE
PURCHASE OF POLICE PURSUIT VEHICLES
(GENERAL SERVICES DEPARTMENT)**

WHEREAS, after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 1:00 pm, on Friday, August 23, 2013, for the purchase of twelve 2014 Dodge Charger police pursuit vehicles at the request of the Forsyth County General Services Department and for use by the Sheriff's Office and the following bids were received:

WHEREAS, it is the recommendation of the County Manager, the General Services Director, and the Purchasing Director that a contract for the purchase of twelve 2014 Dodge Charger police pursuit vehicles for use by the Sheriff's Office be awarded to Horace G. Ilderton, LLC in the amount of \$275,256, with the option to extend the contract at the same annual cost, in one year increments, provided that both parties are in agreement and funds are available for this purpose; and

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of this contract.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Forsyth County, that a contract for the purchase of twelve 2014 Dodge Charger police pursuit vehicles for use by the Sheriff's Office is hereby awarded to Horace G. Ilderton, LLC in the amount of \$275,256 and that all other bids are hereby rejected.

BE IT FURTHER RESOLVED that Forsyth County reserves the right to extend the contract at the same annual cost, in one year increments, provided that both parties are in agreement and funds are available for this purpose.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with Horace G. Ilderton, LLC for the purchase of twelve 2014 Dodge Charger police pursuit vehicles consistent with the terms outlined herein, subject to a pre-audit certificate thereon by the Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
