SUMMARY OF INFORMATION:


The POSSE (Prevent On-going Spread of STI's Everywhere) Program of the Preventive Health Services Division of the Forsyth County Department of Public Health has received a grant totaling \$52,056 from El Pueblo, Inc. to implement an Hombres HIV/STI Prevention, Education, and Outreach Program. This program will deliver important HIV/AIDS and STI information and education to targeted populations in the community through trained peer educators.

Funds will be used for a part time facilitator hired through a temporary service to administer the Hombres program. The facilitator will then have several goals to achieve.

Funds will be used to pay for temporary agency staff time, training, travel, peer educator and participant incentives and program supplies. The Hombres program will support the Department of Public Health's work on HIV and STI prevention and control.

The grant period runs through October 31, 2015.

WHEREAS, El Pueblo Inc., is a nonprofit corporation that recognizes the need to strengthen HIV/STI prevention, education, and outreach efforts in the community; and

WHEREAS, El Pueblo Inc. has awarded a grant in the amount of \$52,056 to the Forsyth County Department of Public Health to implement an Hombres HIV/STI Prevention, Education, and Outreach Program in Forsyth County;

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to execute the necessary documents, on behalf of Forsyth County, for the benefit of the Department of Public Health, to receive grant funds in the amount of \$52,056, from El Pueblo, Inc., to support the implementation of an Hombres HIV/STI Prevention, Education, and Outreach Program, subject to a pre-audit certificate thereon by the Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
