#### FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO 2015-2016 BUDGET ORDINANCE

Each year, the adopted budget includes funds to cover prior year encumbrances. For FY 2015-2016, \$2,000,000 was budgeted in Non-Departmental to fund prior year encumbrances. For FY 2014-2015, actual outstanding encumbrances as of June 30, 2015 totaled \$2,848,172.46. Of the outstanding encumbrances, \$1,857,830 represents the contract with Farragut Systems, Inc. for the NCACC Collaborative Property Tax System (NCPTS) authorized in FY 2013.

This Budget Ordinance Amendment appropriates \$848,172.46 of Restricted Fund Balance to fund these outstanding obligations.

Excluding the Tax System contract, total prior year encumbrances would have been \$990,342.46 and the \$2,000,000 budgeted would have sufficiently covered these outstanding obligations.

A list of the outstanding encumbrances is attached hereto and incorporated herein by reference.
