**Re: CY 2024 Emissions Inventory for Flapaloo Products (Premise 00222)**

Dear Mr. Btfsplk:

This letter is notice that you are required by Chapter 3 of the Forsyth County Air Quality Technical Code, Subchapter 3Q, Rule .0207 and Subchapter 3D, Rule .0202 to quantify your facility's calendar year 2024 air pollutant emissions and report those emissions data to the Forsyth County Office of Environmental Assistance and Protection (FCEAP). Emissions inventory data are utilized in air quality planning, toxic risk assessment, determination of permit fees, satisfaction of Federal emission reporting requirements and other related purposes. You are required to provide your best estimate of actual emissions of each regulated pollutant from all sources of emissions at your facility in addition to information about your processes and emission release points.

Your air emissions inventory must be reported via the Microsoft Access database that is attached to the same email as this notification. Either Microsoft Access 2003 or higher or the free Microsoft 365 Access Runtime environment will need to be installed on your computer to take advantage of this method. **Do not use a database provided for an earlier emissions inventory to submit your 2024 emissions inventory.** The latest version of the database must be utilized in order to incorporate changes to the code tables or the database itself since your last submittal. Please email your completed emission inventory database back to me by **June 30, 2025**.

If you have questions or would like assistance preparing your facility's emissions inventory, you are encouraged to contact your case manager at the Office of Environmental Assistance and Protection at 336-703-2440. Your case manager is familiar with your facility's processes and will be able to provide guidance and assistance with calculating emissions as well as help identify additional information necessary for your submittal.
