## Approval of Absentee Meeting Schedule for the November 3, 2020 General Election

Secretary Durrah moved to approve the Absentee Meeting Schedule for the November 3, 2020 General Election; Member Jourdan seconded; **Motion carried unanimously**.

Consideration of One-Stop Early Voting Plan for the November 3, 2020 General Election

Chairperson Campbell addressed prior meetings and voter concerns about early voting sites and hours, the various ways to vote, CDC safety protocols, State Board of Elections procurement of personal protective equipment (PPE), and costs. Director Tsujii addressed the status of securing Hanes Mall Winston First Assembly Church, and Winston Lake YMCA as early voting sites. Director Tsujii also shared current plans for public engagement about absentee by-mail voting and how to educate voters on the voting process as it relates to COVID-19 during the general election. Chairperson Campbell moved to approve the following sites Forsyth County Government Center; Brown & Douglas; Clemmons Library; Kernersville Library; Lewisville Library; Mazie Woodruff Center; Old Town Recreation Center; WSSU- Anderson Center; Rural Hall Library; Sedge Garden Recreation Center, Southside Library, Walkertown Library, Sprague Street Recreation Center, Winston Lake YMCA, Winston First Assembly (with the contingency of Polo Park Recreation Center in the event the church cannot be secured), and Hanes Mall- former Macy's (with the contingency of Harper Hill Commons Shopping Center and Miller Park Recreation Center in the event the mall space cannot be secured) and the following hours October. 15-16, 2020 – 8 a.m.-7:30 p.m., October 17, 2020 9 a.m.-5 p.m., October 19-23, 2020 - 8am-7:30 p.m.; October 24, 2020 - 9 a.m. - 5 p.m., October 26-30, 2020 - 8 a.m.-7:30 p.m., and October 31, 2020 – 9 a.m.-3 p.m.; Member Russell seconded; **Motion** carried unanimously.

### **Other Business**

Director Tsujii addressed concerns that were brought to the Board's attention regarding Hanes-Lowrance noting that through conversations Mr. Wilson the Hanes side is not available for use as it been taken over by another entity and the Lowrance side was in serious disrepair, did not have access to running water and was a serious security risk for the voting equipment and no additional funds in the budget to refurbish the Lowrance side nor provide extensive security. Director Tsujii stated that an alternate site had already been obtained.
