- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P: The following items measured at temperatures above 41F: (make-unit) sliced tomatoes 45 F, lettuce 42 F, cole slaw 42 F, and sliced tomatoes (2-door upright cooler) 44 F. Potentially hazardous foods shall be kept at a temperature of 41 F or below. 0-point CDI: PIC (person-in-charge) was educated on the new cold holding temperatures as of January 1, 2019
- 31 3-501.15 Cooling Methods -REPEAT-PF: A pan of tomatoes tightly wrapped in the 2-door upright cooler measured at a temperature of 44 F. PIC stated tomatoes had been cut 30 minutes prior. Cooling shall be accomplished in accordance with the time and temperature criteria specified under § 3-501.14 by placing the food in shallow pans, separating the food into smaller or thinner portions, or other methods of rapid cooling. CDI: PIC was educated on cooling the methods. PIC partially uncovered tomatoes before placing them back into cooler for cooling. *Loosely wrap tomatoes before placing in cooler to allow rapid cooling. Cool tomatoes to 41 F or below before placing in make-unit*
- 35 3-302.12 Food Storage Containers Identified with Common Name of Food - C The following items were presented without a label: 1 shaker above grill, 1 shaker above prep sink, and two squeeze bottles above grill. All food containers of food shall be labeled except food that is easy to identify such as dry pasta.

Cloths in-use for wiping counters and equipment surfaces shall be kept in a chemical sanitizer solution with a concentration as specified under 4-501.114
- 47 4-602.13 Nonfood Contact Surfaces-REPEAT - C- Attention needed to shelving throughout the facility. Shelves displayed a grease and dust accumulation. Nonfood contact surfaces shall be cleaned at a frequency to prevent soil accumulation.
- 52 5-501.15 Outside Receptacles - C: There is a hole on the front side of the outside receptacle. Receptacles, refuse units, returnables and recyclables shall be durable, cleanable, pest resistant, leakproof and nonabsorbent. 0-point
- 54 6-305.11 Designation-Dressing Areas and Lockers - C 3-307.11 Miscellaneous Sources of Contamination - C: A pack of cigarettes, a cigarette lighter, and a cell phone were stored on shelving above food prep sink beside handwashing sink. Lockers or other suitable facilities shall be provided for the orderly storage of employee clothing and other possessions. 0-point
