PURPOSE: The Revision For Asbestos/Notification form (Form) is required to report all revisions to an active Forsyth County Office of Environmental Assistance & Protection (Office) Permit for asbestos removal or demolition notification.

PREPARATION: The Form is used to report all revisions that may occur: 1) Rescheduling start and completion dates for asbestos removals or demolitions; 2) Additional amounts of regulated asbestos-containing materials are to be removed; and, 3) Other revisions that substantially alter the originally issued permit or notification (e.g., waste transporters, waste disposal sites, other operators).

INSTRUCTIONS: <u>Complete the facility name and address; contractor's name and address; contact person's name and contact person's telephone number</u>.

- Indicate any revisions in removal or demolition start or completion date(s). <u>Check "on hold"</u> if renovation/demolition project is being placed on hold.
- If the amounts of RACM is being revised, enter the additional amounts in the corresponding blanks and compute the additional fees accordingly.

Enter the certifying individual's name, title, and company name. <u>The certifying individual must sign and date the form as indicated</u>. Renovation revisions shall be completed with an original signature and require submittal via hand delivery or mail service.

GUIDELINES: If a removal and/or demolition is to begin earlier than the original start date, the Office must receive the Form at least 10 working days before the new start date. Removals or demolitions may be placed in "on hold" status; however, the work must be conducted within 12 months from the original start date. After 12 months, the original permit or notification will no longer be valid. The owner or owner's representative must therefore, resubmit a new Asbestos Permit Application and Notification for Demolition/Renovation form, indicating the new start and completion dates prior to resuming work on the project.
