## NOVEMBER 6, 2018 GENERAL ELECTIONS

#### Now through Tuesday, October 31 - 1 Week Prior:

Absentee ballot request forms from any qualified voter may be received now through Nov 1 - G.S. 163-230.1 (a) and (3)

#### Now through Monday, November 6 - 1 Day Prior:

Absentee ballot request forms from any voter with a sickness or a disability may be received now through Nov 7 (in person only Nov 1-7) - G.S. 163-230.1 (a) and (a1)

#### Sunday, July 30 - not later than 100 days before:

Date election notice of all ballot measures, federal, State and local offices that will be on the ballot is to be prepared to be used in conjunction with the federal write-in absentee ballot. G.S. 163-258.16(a)

#### Sunday, October 8 - 30 Days Prior:

If changes in time or additional meetings are to be held, a schedule shall be published in a newspaper circulated in the county and a notice shall be posted at the courthouse door. Similar notice shall be given of the dates and hours of the weekly meetings. G.S. 163-230.1 (c1)

#### Saturday, September 18 - 50 Days Prior:

Date absentee ballots are required to be available. G.S. 163-227.3 (a)

#### **Saturday, September 23:**

Notice of Ad for election date, times, letters of request, applications and One-Stop (In Person) Absentee Voting (20 days and 3 times before primary registration deadline) G.S. 163-33(8)

#### Friday, October 13- 25 Days Prior:

Registration deadline G.S 163-82.6 (c)

#### **No Excuse One-Stop Absentee Voting:**

One-Stop (In-Person) absentee voting in GB and HP offices. Please see schedule - G.S. 163-227.2 (b)

#### **Tuesday October 24 - 2 Weeks Prior:**

Last day to adopt resolution to begin counting ballots between the hours of 2 pm and 5 pm on election day. A copy shall be published once a week prior to the election. G.S. 163-234 (2)
