Free tax filing is available for families earning up to \$52,000 (or \$58,000 if you file your own).

What to bring with you: Picture ID, Social Security card (or Individual Tax Identification Number) for yourself and each dependent (including children) you are claiming, ALL W-2s and/or 1099s, the Employer ID number or SS number of childcare providers, and last year's tax returns. If you want direct deposit of any refund, also bring your checking or savings account information.
