Equipment issues from last inspection have been addressed, however cut outs underneath cabinetry are still not smooth and easily cleanable. Repair to be smooth and easily cleanable or replace. Rewrap pipes on unit in walk in freezer where insulation has deteriorated. Smooth out welds on sides of table between prep units. Equipment shall be in good repair.
- 52 5-501.113 Covering Receptacles - C Dumpster door observed open. Keep dumpster and other outside waste handling containers for refuse, recyclables, and returnables covered with tight-fitting lids or doors. Keep doors closed when not disposing of garbage. Locks may be placed on dumpster to prevent unauthorized access. 0 points.
