- 1 2-102.12 Certified Food Protection Manager - C- A certified food protection manager was not present at the start of the inspection or during hours of preparation prior to opening. A certified food protection manager that has passed an ANSI accredited exam shall be present during all hours of foodservice operation and during the inspection.
  
- 8 5-205.11 Using a Handwashing Sink-Operation and Maintenance - PF- REPEAT- The handsink near the walk in cooler had a sponge stored in the basin. An employee used a handsink to rinse out a wiping cloth. A handwashing sink shall be maintained so that it is accessible at all times for handwashing and may not be used for purposes other than handwashing. CDI- sponge was removed and PIC educated employee to use the utensil sink for rinsing out wiping cloths.
  
- 18 3-501.14 Cooling - P- REPEAT- A large stock pot of soup in the walk in cooler measured 96-98F. This soup had simmered over night and placed into the walk in cooler this morning to cool for use on upcoming days. Staff did not check the temperature of the soup when they arrived this morning. Hot foods shall be cooled from 135F to 70F within 2 hours and from 70F to 41F within 4 hours. It should take no longer than 6 hours to cool foods. CDI- soup was discarded. \*Once the temperature drops below 135F, the cooling process begins and foods shall meet the time/temperature parameters. Temperatures should be monitored during the

Lock process.

- 31 3-501.15 Cooling Methods - PF- REPEAT- A large stock pot of soup with a lid was placed in the walk in cooler to cool. Use approved cooling methods when cooling foods. Methods like: ice bath, shallow pans, loose covers, cooling wands, etc. CDI- soup was discarded.
- 37 3-307.11 Miscellaneous Sources of Contamination - C- A container of carrots and a container of basil were stacked on top of foods in the make unit that did not have lids. The bottom of the containers were in direct contact with foods in the make unit. The carrot and basil containers are placed on the cutting board and food prep table during times of prep and then placed back into the make unit for storage. This is a possible source of contamination. Do not allow the bottom portion of food containers to come in direct contact with foods.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C- REPEAT- Refrigeration gaskets are torn on the sushi cooler and both make units. Maintain equipment in good repair. //4-205.10 Food Equipment, Certification and Classification - C- REPEAT- The Frigidaire upright freezer is not an ANSI approved piece of equipment. Food equipment except for toasters, hot water heaters, microwaves, hoods and mixers shall meet ANSI standards or meet Parts 4-1 and 4-2 of the NC Food Code.
- 49 5-205.15 (B) System maintained in good repair - C- The handsink at the bar is leaking. Both faucets at the utensil sink are leaking. Maintain plumbing fixtures in good repair.
