 Door gasket starting to split on the low boy reach in cooler.
 Equipment shall be maintained in good repair.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - C
 Food debris and stains were noticed on the insides of reach-in coolers and upright refrigerators.
 Coffee grounds and food debris were also noticed throughout the cabinetry.
 Non food contact surfaces of equipment shall be kept free of an accumulation of dust, dirt, FOOD residue, and other debris.
