WHEREAS, on January 8, 2018, a contract was fully executed between Forsyth County and Wake Forest University Baptist Medical Center for mammography screening and diagnostic services in an amount of \$45,500.00; and

WHEREAS, a proposed amendment to the foregoing contract in the amount of \$40,000.00 was submitted for execution, representing a total contract amount of \$85,500.00, which amended contract amount requires approval of the Forsyth County Board of Commissioners;

NOW, THERFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to execute, on behalf of Forsyth County, the amendment to the agreement between Forsyth County and Wake Forest University Baptist Medical Center in the additional amount of \$40,000.00, representing a total contract amount of \$85,500.00, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.

This service contract amendment is between the Forsyth County Public Health Department and Wake Forest University Baptist Medical Center for additional charges incurred because of mammography. chest x-ray, and diagnostic services provided to patients referred by the County. The services provided are mandated by the State and the patients the County referred incurred an expense that exceeds the original contract amount of \$45,500 for FY19. Upon speaking to the department, it appears that there is minimal fiscal monitoring of the program limits. The Department does not communicate to Baptist Medical how many patients can be serviced due to FY budget limits. Therefore, the County is not aware of costs incurred until the services are performed and the invoices are received. The program period of this agreement is July 1, 2017, through June 30, 2018, and requests an additional \$40,000 to cover the invoiced services, the contract shall not exceed \$85,500 for FY18. Due to a \$40,000 interdepartmental transfer from the Medical Supplies line item in Communicable Disease (376021-2562) as of May 22, 2018, the funds are available to cover this expense. However, this item, because of the amount of the contract being over \$50,000, must be briefed before the BOCC prior to the contract amendment being fully executed.
