**COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:**

**SUMMARY OF INFORMATION:**

During the Fiscal Year 2020 budget adoption process, an Alternate Service Level was presented to the Board of Commissioners to fund a new 309 Fire Suppression unit to supplement county volunteer fire departments on complex incidents and provide manpower on calls that require large amounts of manpower.

Currently, Forsyth County has two units (109 and 209) that are stationed in the eastern and western parts of the County. It is proposed that the new 309 unit would be based out of the northern part of the County which would ensure that nearly 80% of rural county residents are covered with a 10-minute response time.

The funds that will be transferred to the General Fund will be used to pay for salaries and benefits, uniforms, operating supplies, and capital outlay associated with the creation of six positions to staff the new 309 unit.
