**SUMMARY OF INFORMATION:**

On August 6, 2020, the Forsyth County Board of Commissioners approved a Capital Projects Ordinance from the sale of two-thirds bonds to provide funding in the amount of \$2,300,000 to meet the capital repair and maintenance needs for Forsyth Technical Community College.

This agenda item is necessary in order for the Board of Commissioners to review the three (3) capital repair/maintenance projects that are proposed to be implemented with the \$2,300,000, and consider approval of an amendment to the Capital Projects Ordinance to include the three projects by reference.

There are no additional financial impacts with this action as these funds have been approved – this is an approval of the projects proposed by Forsyth Technical Community College.

**AMENDMENT TO THE 2020 FORSYTH TECHNICAL COMMUNITY COLLEGE  
CAPITAL MAINTENANCE 2/3RDS BONDS CAPITAL PROJECTS ORDINANCE**

Be It Ordained by the Forsyth County Board of Commissioners that the 2020 Forsyth Technical Community College Capital Maintenance 2/3rds Bonds Capital Projects Ordinance is hereby amended to replace the Ordinance dated August 6, 2020, with the following:

Section 1. Revenue.

The following revenues are hereby made available for the Forsyth County Technical Community College - Capital Maintenance Projects:

Section 2. Authorization for Projects and Appropriation of Funds.

The following projects are hereby authorized and the following amounts are hereby appropriated for said projects:

The County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, the necessary documents to carry out these purposes, subject to necessary Board authorization, appropriation of funds, compliance with applicable bidding and other laws, a pre-audit certificate thereon by the County Chief Financial officer, if applicable, and the approval as to form and legality by the County Attorney. Forsyth Technical Community College is authorized to approve necessary changes to the projects within available funds.

Section 3. Effective Date.

This ordinance shall become effective upon adoption.
