WHEREAS, after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 12:00 Noon, on Friday, February 13, 2015, for the purchase and installation of two 750 gallon indirect water heaters at the Law Enforcement Detention Center with the following bids received:

WHEREAS, it is the recommendation of the County Manager, General Services Director, and the Purchasing Director that a contract for the purchase and installation of two 750 gallon indirect water heaters at the Law Enforcement Detention Center for the base bid amount and Alternate #2 in the total amount of \$149,100 be awarded to K-Ham Plumbing Contractors, Inc.; and

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of this contract.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with K-Ham Plumbing Contractors, Inc., for the purchase and installation of two 750 gallon indirect water heaters for the Law Enforcement Detention Center in the total amount of \$149,100, subject to a pre-audit certificate thereon by the Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.

BE IT FURTHER RESOLVED that all other bids are hereby rejected.
