### SUMMARY OF INFORMATION:

The Personal Health Services Administrative Area of the Forsyth County Department of Public Health has been awarded \$227,500 in additional non-recurring grant funding from the North Carolina Department of Health and Human Services, Division of Public Health, Women's and Children's Health Section, Women's Health Branch for evidence-based strategies that address Infant Mortality Reduction. The funding period for these funds is January 1, 2016 through May 31, 2016.
