Member Loughridge moved to table the Consideration of One-Stop Early Voting Plan for the November 3, 2020 General Election to gain further clarification of Early Voting locations; Member Jourdan seconded; **Motion carried unanimously.**

Other Business

Ms. Stuck presented the Board with Paula Joan McCoy’s Certification of Petition to have the candidates name printed on the ballot as an Unaffiliated candidate for Winston-Salem City Council Northeast Ward in the General Election on November 3, 2020. Ms. Stuck provided the signature requirements and the total number of signatures received and verified.

Director Tsujii answered questions for the Board regarding the absentee ballot process; witness requirements, Military and Overseas ballot requirements that the Board members had received from the public.
