

## Free Tax Assistance by Appointment Only

While AARP WS Tax Aide and IRS Volunteer Income Tax Assistance (VITA) programs will not be offering onsite tax assistance at Forsyth County Library locations this year, they will still be providing tax assistance by appointment only. Begins Jan. 24, 2022, unless otherwise noted. **Dates and times subject to change**

### AARP WS Tax Aide

AARP WS Tax Aide requires that the taxpayer provide a Covid-19 vaccination record card showing proof of being vaccinated. The taxpayer must also have an email account.

1. Obtain a tax packet at Forsyth County Central Library, Reynolda Manor Branch, Southside Branch or Clemmons Branch; or visit [www.wstaxaide.com](http://www.wstaxaide.com) and print the forms.
2. Make an appointment according to the tax packet instructions.

**What to bring:** Photo ID for taxpayer (and spouse if filing jointly); Social Security ID or ITIN ID of each person on the tax return; W-2s, 1099s, social security statements (SSA-1099), all documents reflecting earnings; last year's tax return; all childcare provider names, addresses and employer ID numbers (EIN) or SS numbers; Letter 6419-Advanced Child Tax Credit (ACTC); Letter 6475, Your Third Economic Impact Payment; Notice 1444-C, Your 2021 Economic Impact Payment; evidence of deductible expenses; income and expenses for sole proprietorship (Schedule C); 1095-A form if healthcare coverage is through Marketplace (ACA) insurance; and checking or savings account number for direct deposit of a refund.
