- 8 6-301.12 Hand Drying Provision - PF- No paper towels available in employee restroom. Hand drying provision shall be available. CDI- Paper towels obtained and installed.
- 13 3-302.11 Packaged and Unpackaged Food-Separation, Packaging, and Segregation - P- Opened package of raw pork chops above cheese and raw fish above ready to eat foods in walk in freezer. Foods shall be stacked to avoid cross contamination by stacking in order of final cook temperature in refrigerators and freezers. CDI-Restacked appropriately.// 3-304.15 (A) Gloves, Use Limitation - P-Food employee obtained raw pork chops from freezer, and then proceeded to go to the line and pick up a dry wiping towel after placing chops on grill to cook. Gloves shall be changed, and hands washed, when changing tasks, and between working with raw and ready to eat foods. CDI-Intervention by EHS; gloves and towel removed from use, hands washed, donned new gloves. he

- 18 3-501.14 Cooling - P- Meat sauce in walk in cooler since previous day measured 56F. Boiled eggs cooked at approximately 6am, in make unit, measured 49-55. Boiled eggs in walk in measured 44-45F. Cooling shall be accomplished from 135F to 70F within the first 2 hours, and then down to 41F within the remaining 4 hours, entire cooling process not to exceed 6 hours. If foods are not cooled to 70F within the first two hours, the next stage of cooling can not proceed. When working with ingredients that measure 70F or less, cooling to 41F shall be complete within 4 hours. CDI-Discarded make unit eggs and meat sauce, added ice to eggs in walk in.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P- REPEAT- bologna and ham were 45F, and potato salad and slaw were 42F in top of make unit. Maintain all cold potentially hazardous foods at 41F or less at all parts of the food. CDI- Education, potentially need to turn down thermostat on this unit. Opts.
- 26 7-204.11 Sanitizers, Criteria-Chemicals - P- REPEAT- One bottle labeled sanitizer was above 200ppm, as it bleached the test strip. Sanitizers shall not exceed safe levels. Maintain chlorine sanitizers at between 50-200ppm. CDI-Remade to 50-100ppm.
- 31 3-501.15 Cooling Methods - PF- Eggs and meat sauce did not meet cooling parameters. Change cooling methods to be in compliance. Cooling shall be accomplished in accordance with the time/temperature criteria specified in 3-501.4 by using the following methods: placing food in shallow pans, separating food into smaller or thinner portions, using rapid cooling equipment, stirring the food in a container placed in an ice water bath, using containers that facilitate heat transfer, using ice as an ingredient, other effective methods. CDI-Discarded eggs from make unit and meat sauce. Added ice to eggs in walk in, as they were not above 45F.
- 33 3-501.13 Thawing - C- Upon arrival, sliced deli turkey sitting on counter thawing. Thawing shall occur under refrigeration, during cooking, or submerged in running water with sufficient velocity to flush loose particles. CDI-Placed in refrigerator. Opts.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C- Pepsi machine functions with ice bin open. Small tear in gasket in right door of right make unit. Maintain equipment in good repair. Opts.
- 51 6-202.14 Toilet Rooms, Enclosed - C- Door to employee restroom that opens into kitchen has maladjusted hinge that will not allow for self closure. Except where a toilet room is located outside a FOOD ESTABLISHMENT and does not open directly into the FOOD ESTABLISHMENT such as a toilet room that is provided by the management of a shopping mall, a toilet room located on the PREMISES shall be completely enclosed and provided with a tightfitting and self-closing door.
