Purpose

- To decrease the number of visits to organizations in multiple locations for individuals and families experiencing crisis and trauma; and
- To provide navigation of multiple resources for safety and support both onsite and offsite; and
- To increase collaboration between systems and decrease barriers between systems working on behalf of families.

Family Justice Center Model

The family justice center model is identified as a best practice in the field of domestic violence intervention and
prevention services by the US Department of Justice, developed by Alliance for Hope International, both in the
United States and abroad.

Survivors

Survivors play an integral role in providing feedback and suggestions for service delivery planning, challenges
with navigating systems, and sharing their lived experiences with safety and other important needs. Survivors
also contribute by dispelling inaccuracies about interpersonal violence and how communities can help survivors
thrive.

Trauma-informed Response

- We recognize:
 - Trauma is often the result of an event or series of events that can have long-lasting effects on survivors' inability to function and physical, social, emotional, or spiritual well-being.
 - Experiences can include being a direct victim of violence or witness to violence.
 - Everyone copes and adapts differently.
 - Physical and psychological safety, trust, support, empowerment, collaboration and cultural responsiveness are vital to building successful outcomes.

Types of Services/Assistance Offered with

- Law enforcement, criminal, and civil proceedings
- Victim support, advocacy, safety planning
- Legal consultation and support
- Electronic filing of complaints for Emergency Ex Parte 50B Domestic Violence Protective Order
