1. Minutes/Financial Report

2. Natural Resources Conservation Service

A. Charles Anderson (RC&D), Dick Everhart (NRCS, DC Surry County), and Bern Schumak (NC Clean Water Management Trust) gave presentations to the Board regarding stream bank restoration projects and opportunities for the Board to participate. There were two sessions, one at the beginning of the meeting the other near the end of the board meeting:

In session one, Charles Anderson presented the Board with a stream restoration project in Bethabara Park on Monarcas Creek. Mr. Anderson seeks Board concurrence on the project and the adoption of a resolution naming the board as sponsor of the project. As this was the initial presentation of the project the Board elected not to sign at this time until further review and additional information could be gathered.

In session two, Dick Everhart discussed several restoration projects completed in Surry Co. and informed them of the Surry Soil and Water Conservation District Board's role in this process. He also explained how the conservation easements were held, and offered a copy of Surry's contract between the Board and the landowner. Bern Schumak explained how the Clean Water Management Trustees review grants and some of the ways (Soil and Water Districts) can enhance the grant and the likelihood of a grant being funded.

The board will review the information given in the discussion and will continue researching the process for potential participation.

3. Cost Share Program Report

- 1. Bill George (34-05-07-12) Extension. Mike Bowman informed board that contact was made with Teresa Furr regarding an additional 6 month extension if a design is not received from NRCS by the end of the first 6 month extension. Teresa Furr advised that the design should be done prior to the contract being written therefore an extension could not be made. Kerry Venable would like Randy Blackwood to contact David Williams for clarification on this matter.
