Contract Approvals

Forsyth SWCD CCAP Signs

Members discussed placing signs at CCAP projects that are located in public areas or have educational use. Stickers placed on cisterns would also be helpful in publicizing CCAP. Linda Birdsong and Wendi Hartup will bring cost estimates for these two items to the March SWCD meeting.

NW Envirothon

Beth Tucker made a motion to donate \$200 to help cover expenses for the NW Envirothon. Ed Wall seconded the motion and the motion was passed unanimously.

A2 Spring Meeting

Watershed Inspection Report

The watershed dams have been inspected by Land Resources and there were no problems. One of the land owners is allowing horses to graze on the back slope of the dam. This is in conflict with the terms of the easement and the owners have been made aware of the potential damage to the structure and have agreed to remove the horses.

State Association Dues Increase

NCASWCD has approved an increase in annual dues of \$250 per district for FY 2009.
