Call To Order

The Chair called the meeting to order at 2:20 PM.

Approval of Absentees

There were 15,837 absentees recommended to the Board for approval. Upon reviewing the absentees, Mr. Redding moved to approve all 15,837. Mr. Elliott seconded the motion and it passed unanimously.

There were 131 absentees recommended for disapproval. The Board reviewed the disapproved absentees. Mr. Redding moved to approve CIV17147. Mr. Elliott seconded the motion and it passed unanimously.

Mr. Elliott moved to approve CIV9270. Mr. Redding seconded the motion and it passed unanimously.

While the absentees were being examined the Director asked the Board about counting the absentees on the fast card reader. The Board agreed to count the ballots on the fast card reader.

Mr. Elliott moved to approve CIV2770. Mr. Redding seconded and the motion passed unanimously.

Mr. Redding moved to approve CIV23253, CIV19789 and CIV2780. Mr. Elliott seconded and the motion passed unanimously.

Mr. Elliott moved to approve MIL238 and to approve MIL66 based on the witness signatures being on the inside of the sealed envelope. Mr. Redding seconded the motion and it passed unanimously.

MIL18998 arrived on Election Day prior to the 7:30 deadline. Mr. Redding moved to approve the ballot. Mr. Elliott seconded and the motion passed unanimously.

Mr. Elliot moved to approve MIL35624 and CIV724. Mr. Redding seconded and the motion passed unanimously.

The number of absentee ballots approved totaled 15850. The number of absentee ballots disapproved totaled 123.

The absentee ballots were counted on the fast card reader and entered into the Election Day results.

The Board released election results beginning at 7:30 pm. The Board finished releasing election results at about 2:00 am.
